As a property owner, tenant, or person who has requested notice, please be advised that the County of San Bernardino Solid Waste Local Enforcement Agency (LEA) received and is considering an application to issue a new standardized solid waste facility permit (SWFP) for the Searles Valley Minerals Argus Boiler Ash Landfill #1. The LEA is certified by the Cal Recycle to enforce state laws and regulations at solid waste sites within the County of San Bernardino, including all active and closed landfills.

Description of Project and LEA's Preliminary Determination

The Searles Valley Minerals Argus Boiler Ash Landfill #1 is located at 13200 Main Street in an unincorporated area of San Bernardino County. On December 15, 2021 the LEA accepted for review, the permit application package from Searles Valley Minerals Argus Boiler Ash Landfill #1 requesting to obtain a standardized solid waste facility permit.

The LEA's preliminary determination is that the proposed permit be approved.

The decision to approve or deny the standardized SWFP will be made by the LEA within 45 days of the date the application was deemed complete as required by State statute, and was submitted to Cal Recycle for concurrence.
