Please be advised that the San Bernardino County Solid Waste Local Enforcement Agency (LEA) received and approved a Report of Facility Information (RFI) amendment for the Baker Refuse Disposal Site (SWIS# 36-AA-0049). The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle), to enforce state laws and regulations at solid waste sites within the San Bernardino County, including all active and closed landfills.

Description of Project and LEA's Preliminary Determination

The Baker Refuse Disposal Site is located at 72799 Sodabaker Road, Baker, California 92309. On July 31, 2023, the LEA received a Solid Waste Facility Permit (SWFP) application package for the Baker Refuse Disposal Site to amend the RFI to update information based on "Findings"

identified during the facility's 5-Year Permit Review. The amendment includes an update to the personnel responsible for the postclosure maintenance of the landfill and legal description of the permitted boundary.

The LEA finds that the proposed changes are consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA accepted the RFI amendment on August 29, 2023.
