Please be advised that the San Bernardino County Solid Waste Local Enforcement Agency (LEA) received and approved a Report of Facility Information (RFI) amendment to the RFI for the Mid-Valley Sanitary Landfill. The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle), to enforce state laws and regulations at solid waste sites within the San Bernardino County, including all active and closed landfills.

Description of Project and LEA's Preliminary Determination

The Mid-Valley Sanitary Landfill is located at 2390 N. Alder Ave., Rialto, CA 92377. On February 22, 2024, the LEA received a Solid Waste Facility Permit (SWFP) application package for the Mid-Valley Sanitary Landfill to amend the RFI to update information in the current RFI based on the findings identified during the facility's 5-Year Permit Review completed by the LEA

on December 27, 2023. The amendment includes updates to the figures and tables contained within the JTD, Administrative name changes for the owner and operator, surrounding land uses, to reflect completed construction of the Renewable Natural Gas (RNG) plant, previously described therein as proposed and updates to the Preliminary Closure and Post-Closure Maintenance Plan including updated cost estimates.

The LEA finds that the proposed changes are consistent with all applicable certified and/or adopted CEQA documents, consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA accepted the RFI amendment on March 22, 2024.
